



### Studios on the Park Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (the "Release") executed on \_\_\_\_\_ (date) by \_\_\_\_\_ ("Volunteer") releases Studios on the Park ("Nonprofit"), a nonprofit corporation organized and existing under the laws of the State of California and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for Nonprofit and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with Nonprofit is limited to a volunteer position and that no compensation will be provided in return for services provided by Volunteer; that Nonprofit will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness resulting from Volunteer's services to Nonprofit.

1. **Waiver and Release:** Volunteer releases and forever discharges and holds harmless Nonprofit and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services provided to Nonprofit. Volunteer understands and acknowledges that this Release discharges Nonprofit from any liability or claim that Volunteer may have against Nonprofit with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services Volunteer provides to Nonprofit or occurs while Volunteer is providing volunteer services.
2. **Insurance:** Volunteer understands that Nonprofit does not assume any responsibility for or obligation to provide financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. Volunteer expressly waives any such claim for compensation or liability on the part of Nonprofit beyond what may be offered freely by Nonprofit in the event of injury or medical expenses incurred by Volunteer.
3. **Medical Treatment:** Volunteer hereby releases and forever discharges Nonprofit from any claim whatsoever which arises or may hereafter arise because any first-aid treatment or other medical services rendered in connection with an emergency during Volunteer's service with Nonprofit. Volunteer consents to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during volunteer activity.
4. **Assumption of Risk:** Volunteer understands that the services provided to Nonprofit may include activities that may be hazardous. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release Nonprofit from all liability.
5. **Photographic Release:** Volunteer grants and conveys to Nonprofit, without compensation, all right, title, and interests in all photographs, images, video, or audio recordings of Volunteer or Volunteer's likeness or voice made by Nonprofit in connection with Volunteer providing volunteer services to Nonprofit. Volunteer waives any right to inspect or approve any photographs, images, video, or audio recordings prior to use in any format, including posting to social media.
6. **Other:** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that if any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
